Fees and Charges 2024/25

The Ergon Contestable Works department has undertaken a review of our standard suite of fees and charges for Contestable Work and Public Lighting projects. These new fees and charges will be effective from Monday, 5th of August 2024.

The methodology used to develop the 24/25 fees and charges has been through rigorous review to ensure a fair and reasonable outcome is achieved. The uplift in fees is driven by various factors including but not limited to increased Consumer Price Index (CPI) on labour/material/contractor rates, in-depth analysis on internal resource effort required to complete tasks, and incorporating previously unrecognised services such as concept reviews which is now being captured.

This operational update is effective as of the 5th of August and will supersede the current published Ergon Energy Connecting to the Network Fees and Charges 2023/24. The 2024/25 document will be formally published on the Ergon Energy Network website in the coming weeks.
